"2011 ANNUAL MEETING"

As we have done in the past we all gathered at **The Perfect Spot** for lunch before we adjourned to Steve Nash's hanger for the annual meeting on October 22, 2011. A FMS flag is now displayed proudly on the wall. Miss Earp, as always, joined us but left early for another engagement. The attendance was one of the smallest we have ever had. That makes us wonder if our not sending out reminder post cards had this negative effect.

In my remarks I reminded the cadets that the Directory that has the FMSA members listed, is not to be shared with anyone not a member. Just having name, address, phone number are enough for someone to steal your identity. I referenced the example of how I was able to purchase information on the internet on the woman that killed our son, to assist us in finding out what assets she might have. We received enough information in four hours to have stolen her identity. We also need to identify the people, place & time in the many 1,000's of pictures we now have in our files.

I reminded everyone that (1) the annuals and pictures are property of FMSA and should not be used without written permission, (2) the logos and pictures sold by Kennesaw Printing are their property and are not to be used in any form without permission, and (3) that Kennesaw Printing was appointed as the exclusive vendor of FMSA. at the first FMSA annual meeting.

Elsewhere you will find the results of the audited books for FMSA for the last year. The short version is, we took in and spent within about \$20. for the year. We have enough on-hand for expenses and a nest egg for the next reunion in July 2013. The report was accepted by the members present.

You will also find again the accounting for the Reunion 2011. Please note that a good portion of the costs are paid by donations, thus keeping the registration costs down.

Lastly. elsewhere you will find the budget that was approved at the annual meeting to carry us to the next reunion in 2013. The board has certain fixed costs that reoccur on a yearly basis. The only way of cutting the costs are to cut out one of the newsletters in a non reunion year. This reduces the cost by operations by \$442.50. The board figured that since the newsletters have shrunk to 6 pages, as there have been few articles submitted recently, that this would be a prudent way to conserve the group's resources. There was a suggestion from the floor to ask for donations for the 4th newsletter. We will have it, if we receive the donations.

Zora Mae, Leslie and I spent a week in Florida, as guests of Max & Sue, and were able to look some more for our winter/retirement home. We found a craftsman home in East Palatka, that we loved the inside, but the work still needed to restore it was over and above what we were willing to do, at our age. We spent a day in Palm Coast looking at homes. Really liked the planned community and that we had city water/sewage and that the lots were all a reasonable size. We liked being close to shopping, Daytona Beach, St. Augustine, as well as Gainesville. We did not get the first house we contracted for, but it is a short sale and only 40% of them close. We will continue to contract on homes until we get one.

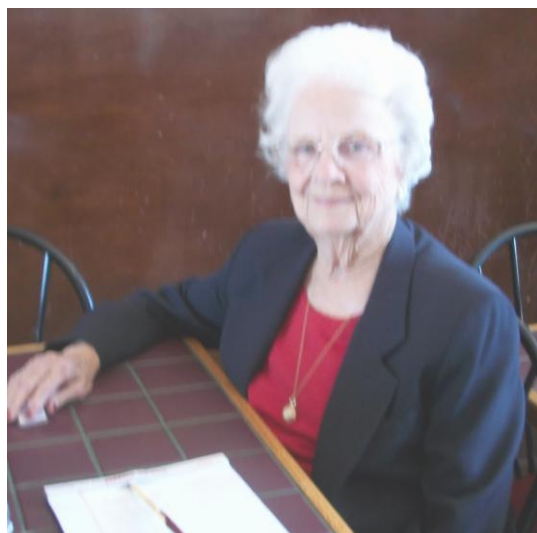

With the money we presently have on hand, we have enough to almost fund four years of operation (with NO income or any expenses) with just the fixed expenses. Basically, we need to keep a “nest-egg” to draw upon in emergencies and to keep the Association solvent and functioning. (We did not really build any “overage” from this year’s reunion towards our operating fund, but we did break even.)

Reunion Financial Report

Our projected budget for this year’s reunion turned out to be right on the mark. We had projected a registration of 60 cadets and 40 guests with a total income of \$5200. In actuality, we had 59 cadets and 45 guests and a total **income of \$5220.**

The projected expenses were also on the mark. Expenses included meals (Saturday lunch and dinner) for all registrants, a gift bag for each cadet, and materials for the Memorial Service and the Hospitality Room.

We received some very generous donations prior to the reunion to aid in presenting the reunion and to include both the DJ and the videographing of the weekend events. The videographer was funded by three major donations from Carl Schaefer, Richard Schaefer and Tommy Crutchfield.

Because of these cadets, we are able to video the class interviews and cover all weekend events and mail a copy to each cadet attendee. The remainder of the donations was used to cover the DJ and other expenses. The **remainder of the donations totaled \$1565.00.** The cost of the DJ was \$600, leaving us **a remainder of \$965.**

The total of the general expenses was: \$1482.88 plus the meals, deposit and room fee to HIE of \$4489, gave us a **total for expenses of \$5971.88.** Total income from **registrations was \$5220.** **This money plus the remainder of the donations = \$6185.**

Total income – total expenses (\$6185- \$5971.88) gives us a remainder of \$213.12.
